On 6/9/26, there was a child asleep on the carpet and not on a required cot in the twelve (12) to eighteen (18) month-old classroom. , Ad Hoc Plan of Action - Anytime a child falls asleep they will be put on a cot. I let the teachers know this as well. Its not okay to sleep on the floor or at the table only on a cot.	7/1/2026
On 6/9/26, while preparing lunch there was a hazard (hot liquid) placed in the children's reach on the edge of the counter causing a burn in the twelve (12) to eighteen (18) month-old classroom. , Ad Hoc Plan of Action - To stop something like this from happening again i removed all the microwaves out of the classrooms and no more cooking or heating up food in their rooms at all. Any liquids even if its cold should be pushed to the back of the counter out of the kids reach. Nothing hot at all should be on the counters. We will also be doing training on how to deal with this type of situation.	7/1/2026
On 6/9/26, there was rough handling of a child. , Ad Hoc Plan of Action - I talked to the Teachers about the way the child was handled even though i know in the moment she was just trying to help the child.
